a county policy is hereby established whereby the County Commission may establish and prescribe its county rules, regulations and policy making decisions, and an affirmative action program.




be it resolved that a copy of the foregoing Resolution be included in the minutes of the Board of County Commissioners of the County of Torrance as a permanent record.





RESOLUTION - January 5, 1993

Whereas the MainStreet New Mexico project has been created to assist communities to develop a public-private effort to revitalize their downtown "MainStreet" areas, and,

Whereas three New Mexico cities or counties may be selected by MainStreet New Mexico, Economic Development Department, to participate in the project in 1993,

NOW THEREFORE BE IT RESOLVED BY THE COUNTY COMMISSION OF THE COUNTY OF TORRANCE that the county:

Section 1: endorses the submission of this application and agrees to participate in the development and support of the MainStreet program.

Section 2: endorses the goal of economic revitalization of the central business districts within the context of the preservation and rehabilitation of its historic buildings.

Section 3: will instruct the county Director of Economic Development to assist in the development of the MainStreet program.

Section 4: will assist in the development of adequate funding to meet the requirements of the New Mexico MainStreet program, including fulltime staff, office space, and training expenses for the minimum three years.

Section 5: will assist the MainStreet program in its efforts to address the issues and goals as identified herein -
