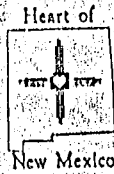




THIS TORRANCE COUNTY DETENTION CENTER OPERATIONS MANUAL
