RESOLUTION NUMBER: 93-48

A RESOLUTION AUTHORIZING THE COUNTY TO SUBMIT AN APPLICATION TO THE DEPARTMENT OF FINANCE AND ADMINISTRATION, LOCAL GOVERNMENT DIVISION TO PARTICIPATE IN THE LOCAL DRIVING WHILE INTOXICATED/IMPAIRED GRANT PROGRAM.

WHEREAS, THE 1993 LEGISLATURE ENACTED CHAPTER 65, LAWS OF 1993 TO ADDRESS THE SERIOUS PROBLEMS OF DRIVING WHILE INTOXICATED/IMPAIRED IN THE STATE; AND

WHEREAS, PROGRAM IS ESTABLISHED TO MAKE GRANT FUNDING TO COUNTIES AND MUNICIPALITIES FOR NEW, INNOVATIVE OR MODEL PROGRAMS, SERVICES, OR ACTIVITIES TO PREVENT OR REDUCE THE INCIDENCE OF DWI, ALCOHOLISM AND ALCOHOL ABUSE; AND

WHEREAS, COMMUNITY, DWI COUNTY PLANNING COUNCIL, AND OTHER GOVERNMENTAL ENTITIES APPROVAL MUST BE RECEIVED IN ORDER TO APPLY FOR GRANT FUNDING; AND

WHEREAS, THE COUNTY ALONG WITH PARTICIPATING AGENCIES IS MAKING APPLICATION TO THE DEPARTMENT OF FINANCE, LOCAL GOVERNMENT DIVISION FOR PROGRAM FUNDING.

NOW THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE COUNTY OF TORRANCE THAT THE COUNTY CHAIRPERSON ON BEHALF OF THE COUNTY AND ALL PARTICIPATING ENTITIES IS AUTHORIZED TO SUBMIT AN APPLICATION FOR PROGRAM FUNDING UNDER THE RULES AND REGULATIONS ESTABLISHED BY THE LOCAL GOVERNMENT DIVISION.
