A RESOLUTION CONCERNING IMPLEMENTING THE THIRD ONE-EIGHTH COUNTY GROSS RECEIPTS TAX IN TORRANCE COUNTY.

WHEREAS, Torrance County has not been able to generate enough revenues to meet the needs of the necessary expenditures within it's budget; and

WHEREAS, Torrance County is growing rapidly and the services of its citizens are increasing with no increase in the revenues, and

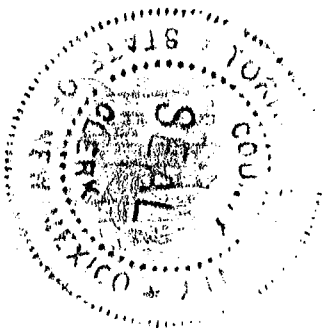
WHEREAS, the Commission finds it necessary to implement the third one-eighth county gross receipts tax; and

WHEREAS, it is necessary for voter approval for the adoption of the third one-eighth increment of the county gross receipts tax; and

NOW THEREFORE BE IT RESOLVED, that the Torrance County Commission is hereby requesting that the question of the passage of the third one-eighth county gross receipts tax be sent to voters by special election ballot.
