FROM: \$37,000 TO \$37,119.61

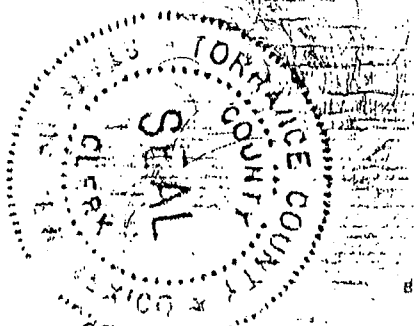
