

NOW THEREFORE, it is respectfully requested that the above request to transfer monies be approved.

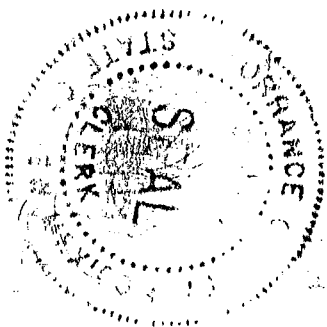

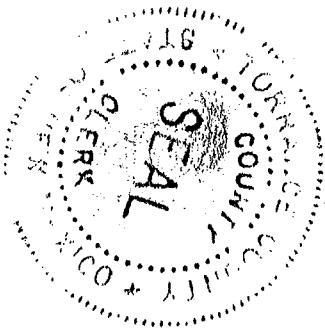
