

## TORRANCE COUNTY RESOLUTION INDEX 2003

- 2003-01:** A Resolution that declares all commission meetings to be open to the public and shall be properly advertised and posted as prescribed by State Statutes. And, whereas, Compilation, moneys so deposited with banks, which have qualified as depositories, shall be equitably distributed between all banks with the county so qualifying.
- 2003-02:** A Resolution whereas any meetings subject to the Open Meetings Act at which the discussion or adoption of any proposed resolution, rule, regulation or formal action occurs shall be held only after reasonable notice to the public.
- 2003-03:** A Resolution whereas Torrance County chooses to designate a successive line of "Official Representatives" whereas in the event one representative could not attend, there would be another designee to take their place.
- 2003-04:** A Resolution whereas Torrance County commission did proposed to authorize a budget increase in the FY 2002-03 Budget.
- 2003-05:** A Resolution authorizing the county to submit an application to the department of finance and administration, local government division to participate in the local DWI Grant and Distribution Program.
- 2003-06:** A Resolution approving and adopting the Torrance County Fire Department Bylaws.
- 2003-07:** A Continued Resolution to 2003-06 whereas the Torrance County Commission passes approved and adopted Torrance County Fire Department Bylaws.
- 2003-08:** A Resolution whereas budget increases requires authorization from the Department of Finance and Administration.
- 2003-09:** A Resolution whereas line item transfers within the same fund requires authorization from the Torrance County Commission.
- 2003-10:** A Resolution whereas the Torrance County Commission does hereby accept Public Roads to be maintained by the County in conformance with Section 67-3-28-3
- 2003-11:** A Resolution supporting President George W. Bush and the Armed Forces in their efforts to suppress the Terrorists and support Freedom throughout the World.
- 2003-12:** A Resolution whereas the Torrance County Departments are requesting line item transfers within the budgeted funds in the FY 2002-03 Budget.
- 2003-13:** A Resolution whereas the Torrance County Departments are requesting line item transfers within the budgeted funds in the FY 2002-03 Budget.
- 2003-14:** A Resolution whereas the Torrance County Commission in regular session on Wednesday, May 28, 2003 did propose to authorize a budge increase in the FY 2002-03 Budget. Budget Increase for the Animal Shelter.
- 2003-15:** A Resolution Imposing a Fee for the Importation of Prairie Dogs into Torrance County.
- 2003-16:** A Resolution establishing the Solid Waste Management Fee as provided in Ordinance 94-12, whereas the Estancia Valley Solid Waste Authority has determined a base rate of \$9.97.

- 2003-17:** A Resolution whereas County Departments are requesting line item transfers within their budgeted funds of the 2002-03 fiscal year budget.
- 2003-18:** A Resolution whereas the Torrance County Commission in regular session on Wednesday, June 25, 2003 proposed a budget increase in the 2002-03 fiscal year budget.
- 2003-19:** A Resolution whereas the Torrance County Commission in regular session on June 25, 2003 proposed a budget adjustment in the 2002-03 fiscal year budget.
- 2003-20:** A Resolution whereas the Board of County commissioners has undertaken a process to develop a Comprehensive Plan for the County, funded in part by a federal Community Development Block Grant administered by the New Mexico Local Government Division, and prepared by the Mid-Region Council of Governments (MRCOG) under a Planning Services Agreement. Passed, Adopted, and Approved.
- 2003-21:** A Resolution whereas the Governing Body in and for the County of Torrance, State of New Mexico has developed a budget for fiscal year 2003-2004 in a Special Board Session on July 29, 2003.
- 2003-22:** A Resolution whereas effective July 1, 2003, House Bill 220 (Laws 2003, Chapter 215) amended the Per Diem and Mileage Act, sections 10-8-1.
- 2003-23:** A Resolution Adopting the Infrastructure Capital Improvements Plan (ICIP), whereas the County of Torrance recognized that the financing of public capital projects has become a major concern in New Mexico and nationally.
- 2003-24:** A Resolution whereas the County of Torrance acknowledges that the State Highway Commission has entered and approved Torrance County's request for participation into the fiscal year 2003/2004 LGRFP for the County Cooperative Program.
- 2003-25:** A Resolution whereas the County of Torrance acknowledges that the State Highway Commission has entered and approved Torrance County's request for participation into the fiscal year 2003/2004 LGRFP for the School Bus Routes Program Project.
- 2003-26:** A Resolution whereas the County of Torrance acknowledges that the State Highway Commission has entered and approved Torrance County's request for participation into the fiscal year 2003/2004 LGRFP for the County Arterial Program Project.
- 2003-27A:** A Resolution whereas the Torrance County Commission in regular session on Wednesday, September 10, 2003 did propose to authorize a budget increase in the FY 2003-04 Budget.
- 2003-27:** A Resolution whereas the Torrance County Commission in regular session on Wednesday, September 24, 2003 did propose to authorize a budget increase in the FY 2003-04 Budget.
- 2003-28:** A Resolution whereas the County Departments are requesting line item transfers within their budget funds in the FY 2003-04 Budget.
- 2003-29:** A Resolution whereas the Torrance County Commission in regular session on September 24, 2003 did propose to authorize a budget adjustment in the 2003-04 FY Budget.
- 2003-30:** A Resolution whereas Governor Bill Richardson joined by Secretary of Transportation Rhonda Faught, and the New Mexico Transportation Commission, announced a bold, innovative new plan to upgrade and improve highways throughout the state of New Mexico called GRIP – Governor Richardson's Investment Partnership.

- 2003-31:** A Resolution whereas Qwest Rural Extension (REF) is intended to provide basic telecommunications service to rural New Mexico.
- 2003-32:** A Resolution whereas the 42<sup>nd</sup> New Mexico State Legislature has provided up to \$500,000 dollars of the Local Governments Road Fund to be expended in the FY2003/04 for the purchase of New Mexico State Highway Department Surplus Equipment for Local governments.
- 2003-33:** A Resolution of the Board of County Commissioners Designating Polling places in each precinct and requiring unobstructed access to at least one voting machine in each precinct for individuals with physical with physical mobility limitations.
- 2003-34:** A Resolution to Determine Designation of Title II and III Funds. Whereas, the Governing Body in and for the County of Torrance, State of New Mexico is required to designate (elect) the formula for distribution of Funds related to the Secure Rural Schools and Community Self Determination Act of 2000.
- 2003-35:** Resolution whereas County Departments are requesting line item transfers within their budgeted funds in the FY 2003-04 Budgets.
- 2003-36:** A Resolution whereas the County of Torrance acknowledges that the State Highway Commission has approved Torrance County's request for participation into the Fiscal year 2003/2004 Local Government Road Fund Program for the School Bus Route Program and the County Cooperative Program.
- 2003-37:** A Resolution whereas the Torrance County Commission in regular session on Wednesday, November 19, 2003 did propose to authorize a budget increase in the FY 2003-04 Budget and it requires authorization from the Department of Finance and Administration.
- 2003-38:** A Resolution whereas County Departments are requesting line item transfers within their budgeted funds of the 2003-04 fiscal year budget.
- 2003-39:** A Resolution whereas the New Mexico Legislature enacted the County Maternal and Child Health Plan Act in 1991. Be it resolved that the Torrance County Board of County Commissioners recognized the important contributions made by the Torrance Health Council to the health and well-being of families and children of Torrance County.
