**A RESOLUTION OF THE TORRANCE COUNTY BOARD OF COMMISSIONERS,
SUPPORTING A REGIONAL ANIMAL SHELTER WITH BERNALILLO COUNTY, TOWN OF
EDGEWOOD, ESTANCIA VALLEY, TOWN OF MORIARTY, MOUNTAINAIR, TORRANCE
COUNTY AND SANTA FE COUNTY BY UTILIZATION OF COLLECTIVE RESOURCES TO
SECURE, OPERATE AND MAINTAIN SUCH A FACILITY**

WHEREAS, Bernalillo County, Town of Edgewood, Town of Estancia, Town of Moriarty, Town of Mountainair, Torrance County and Santa Fe County are responsible for providing animal control services to the public within their respective jurisdictions; and

WHEREAS, It is to the mutual benefit of these governmental entities and their residents that government bodies coordinate their efforts to provide adequate animal control service; and

WHEREAS, The governmental entities recognize a need to coordinate action among the entities to provide effective care for animals and to secure, operate and maintain a regional animal shelter; and

WHEREAS, This shelter will be a joint governmental endeavor to include the joint use of equipment and/or property; and


WHEREAS, Three committees have already been established to identify potential facility location, costs, operational policies and programs;

NOW, THEREFORE IT BE RESOVLED, That Torrance County Board of Commissioners directs County staff to participate in the discussions with the named governmental agencies to further discuss the need for a regional animal shelter and welcome participation of all governments in securing a facility.






