PARTICIPATION IN LOCAL GOVERNMENT ROAD FUND PROGRAM
ADMINISTERED
BY NEW MEXICO DEPARTMENT OF TRANSPORTATION

WHEREAS, the Torrance County and the New Mexico Department of Transportation have entered into a joint and coordinated effort.

WHEREAS the total cost of the project will be \$83,040 to be funded in proportional share by the parties hereto as follows:

New Mexico Department of Transportation's share shall be 75% or \$ 62,280
and
Torrance County's proportional matching share shall be 25% or \$ 20,760

Torrance County shall pay all costs, which exceed the total amount of \$ 83,040

Now therefore, be it resolved in official session that Torrance County determines, resolves, and orders as follows:

That the project for this Cooperative agreement is adopted and has a priority standing.

The agreement terminates on December 31, 2024, and the County of Torrance incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

Now therefore, be it resolved by the Torrance County to enter into Cooperative Agreement Project **SP**. Control Number L500528 with the New Mexico Department of Transportation for LGRF Project for year 2023-2024 to within the control of Torrance County in Estancia, New Mexico. Project Termini is as follows.

**County Roads- Ranger Station Rd. *from Hwy 55 and Beal W. proceed West 1 mile to start of project go .5 miles to end of project.
Red Bluff Road *from Hwy 60 and Third St. Go West .5 miles on Third St.to start of project for 1 mile to end of project*
1 Mile total**

**LOCAL GOVERNMENT ROAD FUND
COOPERATIVE AGREEMENT**

This Agreement is between the **New Mexico Department of Transportation** (Department) and **Torrance County** (Public Entity), collectively referred as the “parties.” This Agreement is effective as of the date of the last party to sign it on the signature page below.

Pursuant to NMSA 1978, Sections 67-3-28 and 67-3-28.2, and State Transportation Commission Policy No. 44, the parties agree as follows:

1. Purpose.

The purpose of this Agreement is to provide Local Government Road Funds to the Public Entity for the **Pavement Rehabilitation/Improvements and Blading and Shaping, various county Roads** as described in Control No. **L500528**, and the Public Entity’s resolution attached as **Exhibit C** (Project). The Project is a joint and coordinated effort for which the Department and the Public Entity each have authority or jurisdiction. This Agreement specifies and delineates the rights and duties of the parties.

2. Project Funding.

a. For purpose stated above, the estimated total cost for the Project is Eighty-three Thousand, Forty Dollars and zero cents (\$83,040.00) to be funded in proportional share by the parties as follows:

1. Department’s share shall be 75%: \$62,280.00

Pavement Rehabilitation/Improvements and Blading and Shaping, various County Roads.

2. Public Entity’s required proportional matching share shall be 25%: \$20,760.00

3. Total Project Cost: \$83,040.00

b. The Public Entity shall pay all Project costs, which exceed the total amount of Eighty-three Thousand, Forty Dollars and zero cents (\$83,040.00).

c. Any costs incurred by the Public Entity prior to this Agreement are not eligible for reimbursement and are not included in the amount listed in this Section 2.
